## 1. DEFINITIONS

*Account* means the account held at your financial institution from which We are authorised to arrange for funds to be debited.

*Act* means the Local Government Act 1989 as amended. *Agreement* means this Direct Debit Request Service Agreement between *You and Us*.

*Business Day* means a day other than Saturday or a Sunday or a Public Holiday listed throughout Australia.

*Debit Day* means the day that payment by you to us is due.

*Debit Payment* means a particular transaction where a debit is made.

*Direct Debit Request* means the Direct Debit Request between *You and Us* (and includes any Form PD-C approved for use in the Transitional Period).

*Transitional Period* means the period commencing on the industry implementation date for Direct Debit Requests (currently 31 March 2000) and concluding 12 calendar months from that date.

*Us or We* means the Australian Labor Party *You* have authorised by signing a *Direct Debit Request*.

*You* means the customer who signed the *Direct Debit Request*.

*Your Financial Institution* is the financial institution where *You* hold the account that *You* have authorised *Us* to arrange to debit.

## 2. DEBITING YOUR ACCOUNT

**2.1** By signing a *Direct Debit Request*, *You* have authorised *Us* to arrange for funds to be debited from your account. *You* should refer to the *Direct Debit Request* and this *Agreement* for the terms of the arrangement between *You and Us*.

## 3. CHANGES BY US

**3.1** *We* may adjust membership fees in accordance with resolutions passed at State Conference. Any other details of this *Agreement* or a *Direct Debit Request* will not be varied without notifying *You* at least fourteen (14) days in advance.

## 4. CHANGES BY YOU

**4.1** Subject to this section *You* may change the arrangements under a *Direct Debit Request* by contacting in writing the Australian Labor Party, 438 Docklands Drive, Docklands VIC 3008.

**4.2** If *You* wish to stop or defer a *Debit Payment* *You* must notify *Us* in writing at least fourteen (14) days before the next *Debit Day*. This notice should be given to *Us* in the first instance.

**4.3** *You* may also cancel your authority for *Us* to debit your account at any time by giving *Us* fourteen (14) days notice in writing before the next *Debit Day*. This notice should be given to *Us* in the first instance.

## 5. YOUR OBLIGATIONS

**5.1** It is your responsibility to ensure that there are sufficient clear funds available in your account to allow a *Debit Payment* to be made in accordance with the *Direct Debit Request*.

**5.2** If there are insufficient clear funds in your account to meet a *Debit Payment*:

**5.2.1** *You* may be charged a fee/and or interest by *Your Financial Institution*;

**5.2.2** *You* must arrange for the dishonoured *Debit Payment* to be made by another method; and

**5.2.3** If *Debit Payments* are continually dishonoured *We* retain the right to cancel the *Direct Debit Request* with *You*.

**5.3** *You* should check your *Account* statement to verify that the amounts debited from your *Account* are correct.

## 6. DISPUTE

**6.1** If *You* believe that there has been an error in debiting your *Account*, *You* should notify *Us* immediately on (03) 9933 8500 and confirm that notice in writing with *Us* as soon as possible so that *We* can resolve your query promptly.

**6.2** If *We* conclude as a result of our investigations that your *Account* has been incorrectly debited *We* will arrange a refund of the incorrect debit.

**6.3** Any queries *You* may have about an error made in debiting your *Account* should be directed to *Us* in the first instance so that *We* can attempt to resolve the matter between *You and Us*. If *We* cannot resolve the matter *You* can still refer it to *Your Financial Institution* which will obtain details from *You* of the disputed transaction and may lodge a claim on your behalf.

## 7. ACCOUNTS

**7.1** *You* should check:

**7.1.1** With *Your Financial Institution* whether direct debiting is available from your *Account* as direct debiting is not available on all *Accounts* offered by financial institutions;

**7.1.2** Your *Account* details which *You* have provided to *Us* are correct by checking them against a recent *Account* statement; and

**7.1.3** With *Your Financial Institution* before completing the *Direct Debit Request* if *You* have any queries about how to complete the *Direct Debit Request*.

## 8. CONFIDENTIALITY

**8.1** *We* will keep any information (including your *Account* details) in your *Direct Debit Request* confidential. *We* will make reasonable efforts to keep any such information that *We* have about *You* secure and to ensure that any of our employees or agents who have access to information about *You* do not make any unauthorised use, modification, reproduction or disclosure of that information.

**8.2** *We* will only disclose information that *We* have about *You*:

**8.2.1** To the extent specifically required by law; or

**8.2.2** For the purposes of this *Agreement* (including disclosing information in connection with any query or claim).

## 9. NOTICE
